Report n. 03: recent developments of Corona Virus in Northern Italy

Dear customers and suppliers,

In all the countries of maximum diffusion of Covid-19, the government authorities are adopting a series of severe restrictive measures, in order to decrease the possibility of contagion among people.

In Italy, on 08.03.2020 was issued a DPCM (government decree-law) with immediate effect and validity until 03.04.2020.

Some areas of Northern Italy had been delimited as "orange zones": the guard level had been raised and regulatory measures restricting the activities allowed to citizens had been applied.

Today, 10.03.2020, the decree has been extended to the whole Italian territory, islands included.

To compensate for the not always complete and truthful information of the media, we would like to point out some of the most important restrictive measures adopted: closure of public gathering places such as cinemas, theaters, museums; cancellation of public sport events; opening hours reduction for bars and restaurants, open until 18.00; precise limitations of proximity and regulation of human contacts between people in public places; limitation of the freedom of movement of people only for proved work or emergency health needs.

TRANSPORT AND MOBILITY

The applied decree **does not impose the blocking of productive activities, work activities nor the blocking of transport and movement of goods.**

It is important to underline that the government **DOES NOT RESTRICT** work activities with any government restriction.

MP3 CRISIS COMMITTEE OF 09/03

In the crisis committee held on 09.03.2020 we raised the level of attention, setting up new procedures to avoid the maximum contact with the outside of the staff employed within the company.



We also confirm the suspension of business trips to customers and suppliers (except in particular and well-grounded situations of need) and vice versa; no supplier and/or customer will be received in the company.

PRODUCTION ACTIVITY IN MP3

Currently, we confirm that our company is completely operative; we are using our FULL production capacity; we receive REGULAR orders, in line with budgets, as well as goods from our suppliers.

Therefore at the moment we are able to comply with the delivery terms and lead times - for sheet and reel orders - agreed with customers.

TRANSPORT IN MP3

In the last two weeks we have been able to satisfy all the requests of our customers, respecting the agreed timing.

We are aware that for some destinations transports may face criticalities or slowdowns. We are however confident that we will be able to work as best as possible in order to solve any problems. We remain at your disposal in case you should encounter difficulties in organizing the transport of materials, from our factory to yours.
