Report n. 04: Decree of 11 March 2020 Coronavirus Italian territory

Dear customers and suppliers,

On 11.03.2020, given the evolution of the epidemiological situation, the governmental authorities have issued a new Decree, in force until 25.03.2020. The Decree establishes new regulatory and restrictive measures for the activities allowed to citizens and public businesses and adopts additional containment measures to manage the health emergency caused by COVID-19.

In particular, there is the suspension of retail commercial activities throughout the Italian territory: essential activities are excluded, such as the sale of alimentary products and basic necessities (pharmacies).

TRANSPORT AND MOBILITY PRODUCTION ACTIVITIES

We confirm that this new Decree does not impose any blocking of production activities, nor the blocking of transport and movement of goods within the Italian territory and/or entering and leaving the national territory.

MP3 CRISIS COMMITTEE OF 11/03: TRANSPORT PROBLEMS

In the crisis committee held on 11.03.2020, we discussed the problem of transports leaving Italy, in particular those of the Brenner-Northern Europe section.

Just to give you an idea of the problem, at 2.00 pm yesterday the queue of trucks leaving the Brenner started from the Bolzano Nord exit and was increasing.

The situation is currently very critical and we are beginning to receive the first cancellations from the carriers.

In the next few days one of our main activities will be to find solutions for the transports that are problematic to organize and/or to confirm.

PRODUCTION ACTIVITY IN MP3

We are in line with what has already been stated in Report no. 03 and therefore we confirm that at present we are using our full production capacity; we receive REGULAR orders, in line with budgets, as well as goods from our suppliers.

Therefore, at the moment we confirm once again that we are able to comply with the delivery terms and lead times - for sheet and reel orders - agreed with customers, except for the problem of transport which begins to be RELEVANT and impacting on the purchase logistics.

COMMUNICATION WITH MP3

We have extended the suspension of business trips to customers and suppliers (except in particular and well-grounded situations of need) and vice versa; no supplier and/or customer will be received in the company.
