## Report n. 06: Extension of Coronavirus decree until 13/04

Dear customers and suppliers,

in the last few days, the epidemiological situation in our area seems to be showing a moderate sign of improvement. Nevertheless, the threshold of attention for the protection of workers and for the guarantee of production continuity remains high.

Government authorities have informed the population that the decree in force until **3<sup>rd</sup> April 2020 will certainly be extended until 13<sup>th</sup> April 2020.** 

In consideration of this Government indication, MP3 has decided the following:

#### <u>SHEETS</u>

In relation to this extension, we confirm that we have extended the **stop of sheet's production until 13<sup>th</sup> April 2020.** 

#### <u>REELS</u>

The reels department remains operative, maintaining 100% of its production **capacity.** As you know, the reels department is largely dedicated to the production destined for the food sector, where we are recording a growing demand for films from Italian and European customers.

## **ACTIVITIES DEDICATED TO WORKER SAFETY**

Regarding the safety of workers engaged in production and office activities, several measures have been taken since 24/02/2020:

- We have applied all the indications of the Italian Health Ministry to reduce the risk of contamination;
- We have purchased and already received safety masks to cover the next 8 working weeks and more are coming;
- We have equipped all workers with transparent protective glasses and disposable gloves;







- We have installed several new positions of hand-sanitizer gel (food-approved detergents) both inside and outside the production area;
- We have activated body temperature detection practices for all the workers present in the factory;
- We have defined new behavior practices and designed new spaces in the workers' refreshment areas to guarantee their 100% safety;
- We have created 30 smart working positions for office staff;
- During the working week, at 9.00 every morning the crisis committee meets by teleconference to monitor the situation, update it and define any additional activities to guarantee safety and production.
